LEGISLATIVE NEWS



STATE

California Subcontractors Legislative Conference on April 2

The second annual California Subcontractors Legislative Conference on April 2nd was considered a great opportunity for subcontractors to capitalize on success in Sacramento. The gathering was organized with the goal of giving subcontractors and suppliers a voice, to have them speak to their legislative representatives and inform them of their view on a few very important legislative bills currently being considered by the legislature.

The day's program began with Marc Connerly, Executive Director, Roofing Contractors Association of California explaining How a Bill Becomes Law. A panel discussion on Surety, Insurance and Contract Concerns of 2014 was led by Anne Wright, Surety Associates of Southern California.

Keynote speaker for the event was Robert Padilla, Small Business Advocate, California High-Speed Rail Authority. He began his talk with a comment that no matter how you feel about this huge project, it will bring jobs to California. He then explained about the phases of the project, how to qualify for the jobs, and how his department intends to make sure small businesses get a share of the work. After lunch, attendees made their way to the State Capitol to talk on the following two bills with their legislators:

AB1705 SUPPORT

Sponsored by ASA California this bill closes a loophole that was inadvertently created in last year's SB293 (Padilla) which capped retention proceeds at 5% on public works projects. The language in that bill also allows public agencies to "declare" a project to be "substantially complex" thereby allowing the agency to exceed the bill's 5% cap on retained payments (retentions). In essence, public entities can circumvent the Legislature's intent in SB293 without legitimate basis and without accountability.

AB2471 SUPPORT

Closes the :change order" loophole in prompt payment laws for public construction projects that lets a public agency owner avoid having to make prompt payment for extra work. Just as all of us must pay our bills on time, the government should as well.

More than 2,000 bills had been introduced prior to the conference,

and dozens of them deal with payments, liability, remedies, bonds, contract rights and obligations, etc.

Planning and marketing the event was a joint effort among the hosting organizations/companies. They determined the day's program, their logo appeared on the conference materials, and their identity and issues were presented to legislators and key capitol staff. LAP&FCA was among the seventeen sponsoring organizations.

LAP&FCA once again had an outstanding turnout with Chapter President Robert Stewart heading the list with board members Tom Unsell, Don Vulich and past chapter president J.R. Grzeskowiak and his wife Nancy attending. May Stewart and Kathleen Unsell also made the trek to the State Capitol along with Executive Director Greg Quinn.

FEDERAL

LAP&FCAs involvement in supporting legislation important to the industry was evident for all to see when nearly half of the FCA International contingent in Washington DC attending the Quality Construction Legislative Conference April 30-May 2 were from LAP&FCA! Attendees were Chapter President Robert Stewart (and May), Board Members Tom Unsell (and Kathy), Don Vulich, and Executive Director Greg Quinn (and Kim). LAP&FCA attendees visited the offices of Rep. Sanchez (D), Rep. Eshoo (D), Rep. Royce (R), Rep. Campbell (R), and Rep. Calvert (R).

The main focus of the conference was on Multiemployer Pension Reform, the critical issue in which a bill is expected to be brought forth from the Workforce and Education Committee in the House sometime before the end of the year. It's a Business and Labor Initiative. The reforms are needed to ensure the longterm viability of multiemployer plans and their contributing employers. The proposal provides private sector solutions that would improve the ability of plans to retain existing contributing employers, attract new employers, improve retirement security for participants, and help prevent future taxpayer dollars from being used to fund the Pension Benefit Guaranty Corporation (PBGC). Plans need tools so plan trustees and bargaining parties can address challenges facing their specific plan.

The Issue

Most employers agree that the current multiemployer system is unsustainable and in need of a serious overhaul. The multiemployer funding provisions of the Pension Protection Act (PPA) will sunset on December 31, 2014, giving the industry a rare window of opportunity to implement needed and lasting reforms.

The construction industry utilizes multiemployer plans. Unlike singleemployee or public plans, multiemployer plans depend on investment income and work hours to fund their benefits. The recent economic crisis and a subsequent decline in work hours have left these plans in a precarious position. It is becoming increasingly difficult for contributing employers to meet their funding obligations and remain competitive in the marketplace.

A significant number of construction industry pension plans are underfunded, putting plans and retirement security for workers at risk. Some plans may become insolvent and require the assistance of the PBGC, which would result in huge reductions in benefits for retired workers (less than \$13,000 per worker per year).

Pension reform is needed to maintain the viability of contributing employers, remove barriers in new construction employers willing to participate in multiemployer pension plans, secure meaningful retirement benefits for workers, and protect the taxpayers and workers from the financial collapse of the current system.

Greg Quinn Recognized

LAP&FCA Executive Director Greg Quinn who retires on June 30 was recognized on April 24 at the annual FCA Leadership Conference in Scottsdale for his dedication to FCA International over the years. The surprise award was given at the historic 130 year-old bunkhouse, Greasewood Flat which was voted one of the "oldest, quirkiest and most classic bars in America. A big western movie fan, Greg appreciated being honored in the old west setting and Tony Darkangelo, FCA CEO, presented a plaque of appreciation to him. A few days later n Washington DC Mike Oscar, FCA legislative director/lobbyist, thanked Greg for being the first FCA representative to the QCA Legislative Conference in 1998 and for his attending nearly every conference since by leading everyone in "He's a Jolly Good Fellow" at the FCA dinner.

The planned format for "Associates Day" didn't happen at the May 13 LAP&FCA Membership Meeting as the Associates turned the meeting into a good natured "roast" with Greg receiving a unique plaque from the Associates Chair Allie Corey (a paint can overflowing with paint - not real paint!) and a lot of well wishes from Associate members.

Emerson College Los Angeles is 2014 Q Award Recipient LAP&FCA is a member of Alliance for Ouality Construction

Emerson College of Los Angeles will be awarded the prestigious Alliance for **Ouality Construction O Award on June** 24, 2014 for its construction of a flashy and technologically advanced LEED Gold Certified 10-story building. This \$85 million, 107,-000 square foot project began in early 2012 and was completed in the fourth quarter of 2013. The new Emerson College campus was union built by Hathaway Dinwiddie Construction Company, and architecturally designed by world-renowned architect, Thom Mavne of Morphosis Architect, a collaborative architectural practice negotiating the technological, political, and cultural intersections of architecture, urbanism, and design.

Emerson College was established in 1880 and evolved from a small New England school of oratory to a multifaceted college with an international reputation. Situated in a lively part of Boston. Massachusetts. Emerson College has offered a semester-long program in Los Angeles built around professional internships since 1986. In 2008, the college purchased a vacant lot in Hollywood and began to develop plans to expand the Los Angeles program and create a permanent home. With over 4,000 alumni living in Southern California, this became the ideal place for Emerson to establish another campus. This campus offers students television, film, journalism, marketing, and communication internships, which assist in their networking base.

With a targeted LEED Gold Certification environmental impact, the construction team was able to create a sun-shading system, connected to a local weather station, that automatically adjusts to minimize the energy used to heat, cool, and illuminate the glass-enclosed residential towers. A valence system, located within the ceilings, is controlled by sensors and provides radiant heating and cooling for the residential units when needed. On top of the West tower, solar thermal panels use the sun to heat water, providing hot water throughout the center and decreasing the building's consumption of natural gas. In addition, the building is equipped with efficient fixtures and on-site water management to reduce water use by 40%.

"It is quite a remarkable feat for a structure of this magnitude and design to become LEED Gold Certified, " said AQCs Chair Pam Ackrich. "Positive results can occur only with a stellar general contractor leading the project, a superb architectural design, cooperation between government and Emerson College, and all union trades working in unison."

The new Emerson College sustainable building is on the lively corner of Sunset Boulevard and Gordon Street, looking North toward Hollywood Hills and a pristine view of the Hollywood sign. The geometry is unique because different viewpoints can cause somewhat of a stunning optical allusion. The bride over the grand stairs also serves as a mounting platform for large video screens transforming the upper portion into an outdoor movie theater. The glitzy building provides 6 general purpose classrooms, a computer lab, an audio lab, a distance learning room, two performance studios, two dressing rooms, two study rooms, a 4k screening room, a multi-purpose event space, and a postaudio mixing suite. Of exceptional note, the event space has advanced audio and visual equipment with seating capacity of 250 persons reconfigurable for special events and parties and the post audio is a 7.1 Dolby surround sound audio suite that is shaped to provide optimum acoustics. The outdoor terrace takes advantage of the Southern California sunshine with a park-like grass area with trees and barbeque grills. The relaxing atmosphere creates social activity and creative cross-pollination. "One must see this structure to realize the incredible final result. Emerson College Los Angeles adds to the growing Southern California Q Award iconic buildings," said Ackrich.

AOCs O Award is given annually for outstanding contributions toward the attainment of quality construction within the building industry of Southern California. The recipient is selected by the Alliance's membership from quality union construction projects completed in the previous year. Recipients of previous Q Awards have been the Red Building at the Pacific Design Center (2013), Providence Holy Cross Medical Center (2012), Los Angeles Unified School District's Robert F. Kenney Community Schools (2011), the LAPD Police Administration Building (2010), LAUSD Ramon C. Cortines School of the Visual and Performing Arts (2009), Nokia Theater at LA LIVE (2008), Renee and Henry Segerstrom Concert Hall in Orange County (2007), The Getty Villa in Malibu (2006), The Home Depot Center in Dominguez Hills (2005),

The 300 Year Old Book Is a Guide to Every Paint Color Imaginable

Long before paint swatches lined the walls of hardware stores, people were still fascinated by color. In 1692, one person from the Netherlands spent what must have been an eternity handwriting and handpainting a stunning book detailing exactly how to make watercolors of different shades. The book caught the eye of Erik Kwakkel, a Medieval book historian from the Netherlands.

From Kwakkel's blog:

In over 700 pages of handwritten Dutch, the author, who identified himself as A. Boogert..describes how to make watercolor paints. He explains how to mix the colors and how to change their tone by adding "one, two or three portions of water". To illustrate his point he fills each facing page with various shades of the color in question. *Continued on page 8*

To top it he made an index of all the colors he described, which in itself is a feast to look at..In the 17th century, an age known as the Golden Age of Dutch Painting, this manual would have hit the right spot. It makes sense, then, that the author explains in the introduction that he wrote the book for educational purposes.

As the book was painstakingly handwritten, it's unlikely that many people saw it when it was first created. But now all 700+ pages of the book (including covers) have been scanned and can be viewed online at e-corpus, a collective digital library.

Wage Theft is a Crime Website - Campaign Launched by California Labor Commissioner

California launched a website and campaign April 30 to educate workers and employers in agriculture, construction, hospitality and other low-wage industries about California labor laws. Users can file claims online at http:// www.wagetheftisacrime.com and www.RoboDeSueldoEsUnCrimen.com for unpaid wages; labor law and prevailing wage violations, and retaliation, and get information about what constitutes wage theft, the Department of Industrial Relations Division of Labor Standards Enforcement said.

"Immigrant workers in low-wage industries are especially vulnerable to wage theft, but may not be aware of their rights, may fear retaliation, or may mistakenly believe that they are not protected, "Labor Commissioner Julie Su said in a statement. Under the California Private Attorneys General Act of 2004, Lab. Code Section 2698 et seq., employees may sue for labor violations on behalf of themselves or other employees - current or former. A portion of the penalties goes to the Labor and Workforce Development Agency for labor law education and enforcement, including funding the new website.

Labor Praises Effort, Calls for More Resources

"Julie Su is engaged in a herculean effort to combat wage theft," Steve Smith, spokesman for the California Labor Federation, told Bloomberg BNA in an e-mail April 30, commending the director and department for their tenacity.

The federation is made up of more than 1,200 AFL-CIO and Change to Win unions representing members in construction, manufacturing, retail and other industries, according to its website. "Problem is, the practice of wage

theft has become so pervasive that it's an impossible task for any one agency, given current resources, to weed out wage theft and prosecute those responsible," Smith said. The San Francisco Office of Labor Standards Enforcement, which oversees that city's minimum wage law, said in a report for the 2012-13 fiscal year that the agency collected \$1,483,048 in back wages an interest for workers, a 32 percent increase over the prior year.

Wage Law "Seems to Be Working"

Christopher E. Cobey, a partner with Littler Mendelson PC, told Bloomberg BNA that the state Wage Theft Protection Act "seems to be working as intended once it finished its somewhat rocky introduction in 2012." "To date, it has not appeared as the subject of substantive discussion in any California state or federal case. The DLSE tweaks to its implementation, as reflected in its revisions to its FAQs in 2012, seem to have brought a level of understanding and predict ability to the employer community as to the requirements of its implementation, "Cobey said in a May 1 e-mail.

The DLSE, also known as the labor commissioner's office, said the state will reach out to community based organizations, and use print, radio and online media to connect with a broad range of low-wage workers. English and Spanish advertisements and radio spots are slated to run statewide with print ads to the San Francisco Bay Area to be published in Chinese, Vietnamese, Hmong and Tagalog.
