### **SB 95**

As you know, things are still constantly changing in regard to COVID-19. We will continue to update our members as we receive information, but for now, here is a hot item you should know about:

- SB 95 COVID-19 Emergency Supplemental Paid Sick Leave Law (Retroactive)
  - Govenor Newsom recently signed SB 95 which mandates that employers with 26+ employees must provide additional paid sick leave for various COVID-related absences. This is retroactive to January 1, 2021 and is effective through September 30, 2021. If you missed our webinar on this topic, the recording and related documents are now available on our website.
