UPDATE: Cal OSHA Postpones Vote on COVID Emergency Temporary Standards Amendments

On May 7, 2021, Cal/OSHA posted new proposed amendments for its Covid-19 emergency temporary standards. (https://www.dir.ca.gov/oshsb/documents/COVID-19-Prevention-Emergency-txtcourtesy-Readoption.pdf)

At the recent meeting on May 20th, Eric Berg, the Deputy Chief of Cal/OSHA asked that the Standards Board not vote to adopt Cal/Osha's proposed ETS amendments.

Berg asked that Cal/Osha be allowed to present a new proposal for adoption at a future meeting with a targeted effective date of June 15, 2021 for its new proposal. Berg cited the new developments of the CDC's updated guidance to allow fully-vaccinated individuals to forego masks in some situations and California's announced goal of fully reopening the state by June 15th, as the reasons for the postponement.

Governor's Executive Order N-84-20 and Updated Guidance from the Department of Public Health

On May 13th, the Center for Disease Control (CDC) updated its guidance for fully vaccinated individuals. The new guidance identified circumstances in which fully vaccinated individuals do not have to wear face coverings, including indoors. However, fully vaccinated individuals must still comply with federal, state, local, or workplace guidance for face coverings. Earlier in the month, the CDC also issued guidance easing outdoor mask requirements in non-crowded gatherings or when gathering with other vaccinated individuals.
