LAPFCA Legislative Report - July 2021

LAPFCA has been working with our lobbyists at the Politico Group to ensure that we are fighting for those legislative changes that will positively impact our contractors' businesses.

The California State Legislature has crossed the midway point of the 2021 Legislative Session. Legislators had until June 4th to move sponsored legislation out of their house of origin. Bills that did not clear that hurdle must be shelved for the year.

It is noteworthy to mention that SCGMA's position on certain legislative issues have changed.

- **AB 712 (Calderon) County of Los Angeles Change Orders** - Position: *Active* -> *Support*
- **AB 416 (Kalra) California Deforestation-Free Procurement Act: Public Works Projects: Wood** - Position: *Oppose* -> *Active*
- **SB 727 (Levy) Labor-Related Liabilities: Direct Contractor** - Position: *Oppose* -> *Active*
- **SB 607 (Min) Professions and Vocations** - Position: *Pending* -> *Support*

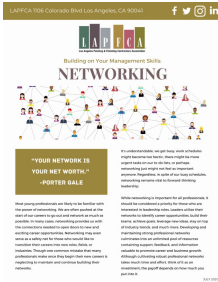
