## SUPREME COURT STAYS THE OSHA "VACCINATE OR TEST" TEMPORARY STANDARD

On Thursday, January 13, 2022, the Supreme Court ruled 6-3 to block OSHA's emergency temporary standards (ETS) "vaccine-or-test" rule mandating that large private employers, with 100 or more employees institute a policy requiring their employees be vaccinated against Covid-19 or undergo weekly testing. The Court ruled to block implementation of the ETS because a majority of the Court found that OSHA had exceeded its authority in enacting the emergency rule.
