Executive Order on Use of Project Labor Agreements For Federal Construction Projects

On February 4th, 2022, President Biden signed an Executive Order requiring project labor agreements on federal construction projects over \$35 million dollars.

The Order is focused on strengthening Union jobs in construction, expanding the federal government's use of PLAs and 'will improve timeliness, lower costs and increase quality in federal construction'.

COVID-19 Supplemental Paid Sick Leave Reinstated

On February 9th, 2022, Governor Newsom signed Senate Bill SB 114 which reinstates up to 80 hours of COVID-19 related Supplemental Paid Sick Leave (SPSL) for all employees working for California employers who employ more than 25 people.

The SPSL becomes effective immediately as the statute applies retroactively to January 1, 2022 and ends on September 30, 2022.
